Concerns with lack of respite, staff wellness, Education, covid – and staff shortages, older carers, and state of caring. Active social media platforms have misinformation as messaging which can be a concern for some families, especially in the 'Enabling Good Lives' messaging and funding.

Current Position:

From September 2021 – May 2022 we have had 1149 workshop participants and 30 workshops throughout New Zealand. This equates to an average of 13 attendees per workshop. We have also facilitated 12 Kitchen Tables around New Zealand including online learning opportunities through Zoom.

We continue to be challenged by Covid, and most families and Whanau are wanting to return to face-to-face learning.

We continue to note that face-to-face information sharing is estimated to be 14 times more effective than other forms of communication and the benefit of having one person attend a face-to-face session can positively impact an entire family/personal network.

Overall Care Matters participants consistently give workshops a high satisfaction rating (for this reporting period we currently have 96% of participants rating Care Matters workshops between good to excellent).

Over these 9 months, 12% of workshop participants were Māori, and 10% were NZ European/Maori. The people who attend the workshops are predominately European women (55%), Chinese (2%), Indian (2%), 10% indicated other, and 9% did not indicate ethnicity.

Update - Summary of Care Matters results and achievements (Tina Lincoln)

At the current time, we are tracking to complete all 37 workshops and 15 Kitchen Tables for the 2021 – 2022 contract round.

We continue to have a positive relationship with our contracts Manager who has transferred from the Ministry of Health to Whaikaha – Ministry of Disabled People.

The Advisory Group was provided with a summary of results from:
